## Bill of Sale

Seller is the legal owner of the puppy or puppies described below. Whereas Buyer(s) agrees to purchase Puppy(ies) for \$\_\_\_\_\_.00 with FULL AKC REGISTRATION, as defined by the American Kennel Club, for each puppy, in accordance with the terms of this agreement.

Seller agrees to hold said puppy(ies) with a non-refundable deposit of \$\_\_\_\_\_.00 for each puppy being held. All deposits, once received, will be deducted from the agreed sale price and are non-refundable in the event the buyer does not buy the puppy.

Seller is not responsible for any shipping or transportation of said puppy(ies) without an agreement, in writing, with the seller ahead of time. Seller states that the puppy(ies) have been examined by a board-certified veterinarian and are in good health. Precautions have been taken to prevent the puppy(ies) from having hereditary defects and, due to unknown causes, no guarantee will be given against such defects. A FULL AKC REGISTRATION will be given to Buyer at time of final payment and/or pickup of the puppy(ies). Puppy(ies) must be fed Purina Pro Plan for Puppies for the first year. If breeding, or attempting to breed, all warranties shall be null and void.

We do not guarantee against worms, viruses, infectious diseases, parasite, coccidian, giardia, mites, cherry eye, hernia, or vaccination reactions.

This is not being sold for resale. If you can no longer care for the puppy, we have the right of first refusal. There are no refunds given for changing your mind. This contract is under the jurisdiction of the state of Tennessee and the agreed place of venue shall be Hamilton County of Tennessee.

All puppies will have been examined by a board-certified veterinarian and, for the warranty of the puppy(ies) to be accepted, they must see a board-certified veterinarian within forty-eight (48) hours from the time of purchase. If, during that time, the buyer’s board-certified veterinarian discovers hereditary health issues that the seller was unaware of and had not mentioned prior to the date of purchase listed above, the seller will, at their discretion, take the puppy back and replace it with a puppy from another breeding so long as diagnosis and request are in writing to Seller’s veterinarian within one (1) year of the puppy(ies) birth date. This warranty is given only to the original buyer(s). All veterinarian fees and expenses shall be the responsibility of the Buyer(s).

By signing the above agreement, the Buyer(s) acknowledge that all terms have been accepted by the Buyer(s). The examination by a board-certified veterinarian will occur within forty-eight (48) hours from time of sale. If the examination is performed after forty-eight (48) hours from the time of sale, the puppy(ies) is/are accepted by the Buyer(s) “As-Is”, with no recourse against the Seller. Proof of examination will be provided to the Seller, if requested. If puppy(ies) is/are returned, for some agreed upon reason, all accumulated costs will be the responsibility of the Buyer(s).
